Mrs. Beth Norman, Bruning Principal reported:

Mrs. Casey Orellano, LJ Stevens Intermediate Principal reported:

We wrapped up Book Blast on Friday, 2/2 and raised \$10,198.33 for books for students. Every student will receive at least one book. Books will be delivered in the coming weeks. 3rd Grade hosted their annual, "Stock Up for Spring" fundraiser during the week of February 5. Mr. Adam Spicer, Wilmington Middle School Principal reported:

High School guidance department has begun the process of scheduling 8th grade students for high school classes. The guidance department met with all 8th grade students on Friday, February 2nd. The registration process for classes will take place February 15th and February 16th. State mandated testing windows officially open in March. WMS students will take the Illinois Assessment of Readiness (IAR) in March and the Illinois Science Assessment (ISA) in April. AIMS Web winter benchmark testing ended in January. Students were tested in Reading and Math. The RTI team has met to analyze testing data, and changes to our RTI classrooms were made. All 8th grade students will take the Illinois Youth Survey on Wednesday, February 7th. Congratulations to the WMS Wildcats of the Month for January: 6th - Charlie Prendergast; 7th - Kailyn Winkle; 8th -Samantha Cutter. CO-CURRICULARS: 7th and 8th grade girls' volleyball teams are participating in the IVC Tournament; Scholastic Bowl matches began this month. Math competitions will also take place this month. Play tryouts for the spring play will take place February 21 and 22. The play will run for two nights on April 30 and May 1. The WMS Cheerleaders will compete at the IESA state tournament on Wednesday, February 7th in Peoria.

Mr. Scott Maupin, Wilmington High School Principal written report:

3 rd Quarter Progress Reports are due February 16th. Parents will be notified via email. We begin SAT Test prep for juniors tonight. SAT/PSAT will be administered on Wednesday April 11, 2024 Testing Day for Juniors, Sophomores, and Freshman on chromebooks. Our Guidance Department is continuing registrations for our Juniors, Sophomores, and Freshman for next school year. We will have Department Meetings and review the Illinois Literacy Plan focus during our SIP Day on 2/7/24. Congratulations to Katelyn Walsh and the WHS Speech Team for their season success by earning 3rd place at the ICE Tournament hosted by Reed-Custer HS. We had Channing Sexton earn a 1st and 3rd place finish while Emilia Williams earned a 3rd place medal. The IHSA Speech Regional were held February 3rd at Coal City. Junior Evan Surdey placed in Radio Speaking and now advances to the Sectionals. The IHSA Sectional will be at Morris on February 10th. The State Finals is at Peoria on February 16th and 17th. Peotone High School hosted the ICE Conference Math Competition on Wednesday January 24th, 2023 for 8 schools. We earned 5th place. Cheerleading State Finals were held on February 2nd and 3rd in Bloomington. We are proud to say that we finished 5th overall at the IHSA State Finals. The team was outstanding all season. We hosted the IHSA Wrestling Regionals on Saturday February 3rd. We had 4 individuals advance to the IHSA Wrestling Sectionals. Senior Landon Dooley, Freshman Oakley Rivera, Senior Parker Adams, and Sophomore Logan Van Duyne will advance to the Sectionals at Chicago Hope Academy. Girls Basketball Regional is slated for February 10th thru 15th. We will play at Reed-Custer in the Opening Round at Braidwood on Saturday February 10th at 1:00 pm. Mr. Mike McCorminck, Technology Coordinator reported:

Mr. Kevin Feeney, Finance report:

Mr. Matt Swick, Curriculum Director reported:

On Wednesday February 7, we had a ½ day of release time for school improvement / staff development. Our elementary staff participated in workshops with Math consultant Cheryl Beasley. The focus was on the effective use of our Go Math resources, as well as on the shared understanding & prioritization of learning standards, IAR math assessments, etc. Middle and high school staff (math and English) participated in articulation meetings together, in striving towards consistency and coordination in grades 6-12. A few staff members will be attending the Illinois Reading Council annual state conference in Springfield in March, while one of our high school CTE teachers will also be attending a state-wide career & tech education conference in Peoria in mid-March. Student Recognition The annual student recognition ceremony for students who Exceed Expectations on the spring state tests will be scheduled to take place tonight's Board meeting. Illinois State Scholars will be formally recognized at the March board meeting. Grants Update Amendments including final allotments for both Pre-K and Title I grants have been submitted and approved. We will be receiving funds from the METT grant which was received by WILCO. This year, some of these funds will be used to assist in updating our autocad drafting lab at WHS. Textbooks & Resources After reviewing multiple textbook series and participating in demonstrations from 4 different publishers. we have narrowed down the middle school Math adoption to two finalists. We are planning for 6-week pilots in which we will be utilizing materials from both finalists to assist in making of the final recommendation. Testing & Assessment The initial testing period for the state IAR assessment will be taking place at WMS in in mid-March and at Stevens Intermediate in early April. All of our juniors will also be taking the state required SAT exam again this year on April 10th.
